Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW OR REGULATION.

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH FORM A CONTRACT. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITY OBLIGATIONS ON THE PART OF ENTRANT AND A LIMITATION OF ENTRANT'S RIGHTS AND REMEDIES.

1. ELIGIBILITY: This Sweepstakes is open to legal residents of **AL, CA, CO, DE, FL, IA, ID, IL, IN, KS, KY, LA, MI, MO, MS, NE, NV, OH, OK, RI, SC, TN, TX, UT, VA, WA, WI, & WY**, who are eighteen (18) years of age or older (OR THE AGE OF MAJORITY IN YOUR STATE OF RESIDENCE, WHICHEVER IS OLDER), at the time of entry (the "**Entrant**"). 2. SWEEPSTAKES TIMING:

The Advance America Fast Cash Sweepstakes (the "**Sweepstakes**") entry begins Monday, April 23, 2018 at 12:00:01 a.m. (midnight) Eastern Time ("**ET**") and ends Wednesday, May 23, 2018 at 11:59:59 p.m. ET ("**Sweepstakes Period**"). The Sweepstakes will consist of ten (10) drawings being conducted Monday-Friday starting on May 10, 2018 and ending on Wednesday, May 23, 2018 plus one (1) Grand Prize drawing to be conducted on Thursday, May 24, 2018. Once you submit a valid entry, it will be carried forward to all remaining drawings (if any remain).

Only entries that include a fully compliant entry (completion of all required fields on the entry form) will be eligible for the Sweepstakes.
